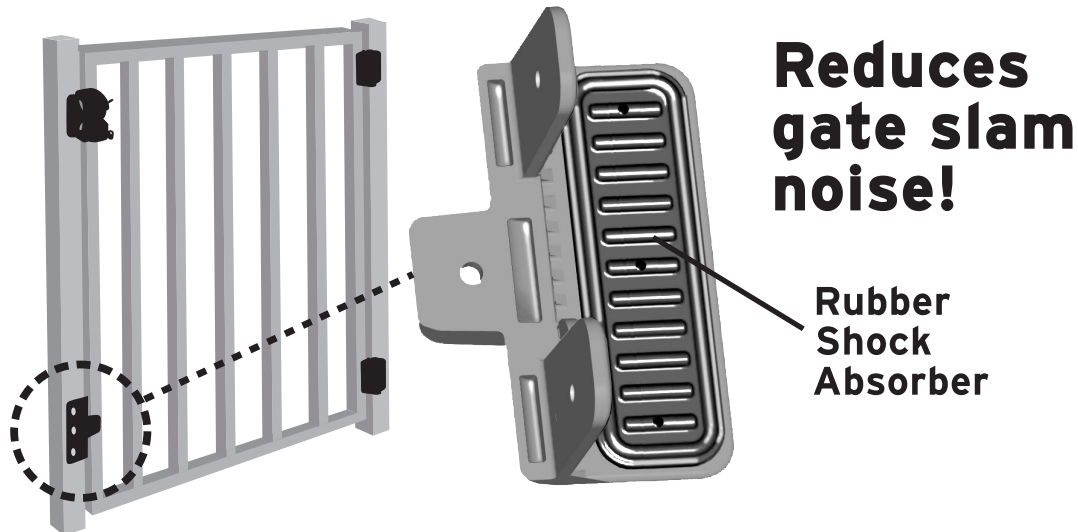


INSTALLATION INSTRUCTIONS

'Soft & Quiet' GATE•STOP



Congratulations on your purchase of D&D Technologies' Tru-Close® Gate•Stop™. We are confident that this product will provide you with a lifetime of quiet gate closure and reduce the damaging effect of gate slamming (see limited Lifetime Warranty below).

Note: The Gate•Stop should NOT be used on gates leading to swimming pools as it may provide a hand- or foothold for a child to use to gain access to the pool area.

Tools required: Electric or cordless drill with #2 Phillips-head driver, 5/32" (4mm) drill bit (use 10-gauge screws).

Installation procedures:

1. Determine the position of the Gate•Stop™ on your gate. For optimal performance, mount the Gate•Stop towards the bottom of the gate. For tall gates, two Gate•Stops may be required. If two are used, mount one at the bottom and the other at the top of the gate. **Note:** Do not mount the Gate•Stop to the fence post as it may present a tripping hazard.
2. Once the correct position has been determined, mark the five holes for drilling.
3. Remove the Gate•Stop™ and pre-drill using the 5/32" (4mm) drill bit.
4. Mount the Gate•Stop™ with the 10-gauge screws using the use the #2 Phillips driver.
5. Your Gate•Stop is now ready for use. Periodically retighten the screws to ensure a strong hold and reliable operation.
